- FACILITY:** Competition Pool: One 50-meter pool with ten-7.5-foot wide lanes each with non-turbulent lane markers. Daktronics 2000 Time System will be used. For all sessions, lanes 1-9 will be utilized for competition, with lane 10 reserved for warm-up and warm-down. In the event of circumstances necessitating changes during the meet, information will be updated on the FAST website at www.fasttigers.com. Balcony spectator seating is available.
- PARKING:** Free parking will be available in the lots adjacent to the Fishers HS Aquatic Center.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern the meet. Please pay special attention to rule 202.3.2 that states, "At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition and warm-down. The Meet Director or Meet Referee shall assist the member in making arrangements for such supervision.
- ELIGIBILITY:** Age as of June 26, 2008 shall determine the age for each swimmer entered into the meet. All swimmers must be registered with USA Swimming. These registration numbers must accompany entry. Coaches must constantly display their USA Swimming coach credential to gain deck access. The meet referee or meet director reserves the right to ask for coach credential display and/or deny access if the coach does not comply.

MEET FORMAT: The meet will be swum in accordance with the accompanying schedule of events. The 11-12 400 Freestyle, Senior 800 Freestyle and Senior 1500 Freestyle will be timed finals events.

Entries shall be limited so that morning prelims sessions will conclude by 12:00 Noon and afternoon prelims sessions will conclude by 4:30 PM.

ALL RELAYS ARE TIMED FINALS..THE FASTEST HEAT FOR 10-UNDER, 11-12, 13-14 AND SENIOR EVENTS WILL SWIM IN FINALS EXCEPT SUNDAY WHEN ALL RELAYS WILL SWIM IN THE PRELIMS SESSION.

The Senior 1500 Freestyle, Senior 800 Freestyle and 12-Under 400 Freestyle will be swum fastest to slowest and alternate women & men depending on the number of heats of each.

The Fishers Area Swimming Tigers reserves the right to **limit the number of heats in all individual timed finals events to keep the time line manageable.** There will be refunds for any event that is limited.

All 1500 Freestyle and 800 Freestyle swimmers are required to provide one timer and one lap counter.

Thursday night will be timed finals. Preliminaries will be conducted on Friday, Saturday and Sunday mornings for 13-14 and Senior events, and Friday, Saturday and Sunday afternoons for 11-12 and 10-Under events. There will be a championship final (top-9) for the 10-Under age group and consolation and championship finals (top-18) for 11-12, 13-14 age groups and a bonus, consolation and championship finals (top-27) for the Senior age group.

If a swimmer misses their event, they will be declared a “no show” and will not be placed in any other heat to make-up the swim.

Fishers Area Swimming Tigers reserves the right to use “fly-over” starts for all events.

ENTRIES:

Enter each swimmer with their full first name, last name, age and USA Swimming number on the entry. All times must be submitted in **LONG COURSE METERS TIMES AND COMPLETED TO THE HUNDRETH OF A SECOND. CONVERTED TIMES MUST USE THE HY-TEK TIME CONVERTER.**

Each swimmer will be limited to three (3) individual events and one (2) relays per day. If an entry is submitted with an individual entered in more events than this rule allows, the entry will be made by order of events starting with Event #1 until the rule is satisfied; there will be NO refunds.

FAST reserves the right to determine which entries to accept. Among the items FAST will consider when making these determinations are: teams will not be broken, number of officials and volunteers provided by the team, balance of age group and gender in entry, level of competition and geographic location.

The Fishers Area Swimming Tigers reserves the right to **limit the number of heats in all individual events to keep the time line manageable.** There will be refunds for all swimmers that get cut out of events.

Those events will have a positive check-in and will be deck seeded.

All scratches for these events are due at the end of the previous night's finals, except the 11-12 400 Freestyle and Senior 1500 Freestyle will have a positive check-in between 3:30-4:30 PM on Thursday. For preliminaries and finals, please check posted heat sheets and report to the proper lane and heat.

ENTRY FEES: All entry fees must be paid by June 19, 2008. Please make check payable to: **FISHERS AREA SWIMMING TIGERS**. The individual events that are timed finals (8-Under Events, 12-Under 200 Back, 12-Under 200 Breast, 12-Under 200 Fly, All Thursday Night Events & Sunday 800 Free) are \$4.00. The individual events that are prelims/finals are \$5.00 per event and all relays are \$6.00 per relay.

There is also a \$1.50 per swimmer, per meet, Indiana Swimming surcharge which must accompany entry.

DECK ENTRIES: Will be accepted if the meet is not filled on **ONLY** as **NEW ADDITIONS**; **CHANGES WILL NOT BE ACCEPTED**. Entry fee for deck entries are \$10.00 per individual event.

DEADLINE: We expect this meet to fill up very quickly. **Entries will be accepted immediately. The final entry date for entries to be received is 5:00 PM ET on June 6, 2008 or when the meet is full, whichever is later. Teams not accepted will have their entries returned as soon as possible, but no later than by June 11, 2008 via email or US Postal depending on the form of entry.**

Any accepted team entries may be updated until midnight on June 23, 2008. Updated times must be received via email. **NO PHONE UPDATES WILL BE ACCEPTED.**

The entry deadline will be extended if the meet is not full. Email confirmation of receipt will be returned. All email entries must be followed by a paper entry and check for entry fees. Please make your check payable to Fishers Area Swimming Tigers and enclose it in your entry. The meet will be run using Hy-Tek Meet Manager computer program (do not forget to "age up" swimmers to 6/26/08).

A printed copy of your meet entries must follow your submission of your entries via email. **In all cases, the printed copy is the final word in any disputes involving entries.** Entries not submitted via email in Hytek format will be subject to a \$50.00 data processing fee.

- 8-Under, 10-Under, 11-12 Age Groups - Awards for 1st through 9th place in all events.
- Team awards will be presented for 1st place, 2nd place and 3rd place visiting teams.
- High point award (1st through 3rd) - 8-Under, 10-Under, 11-12, 13-14 & Senior Age Groups. High point awards will be scored by the swimmers age and scoring will include all events for that swimmer.

OFFICIALS: The FAST will need the help of your **USA Swimming Officials**. If you have a member that is in charge of your officials, please provide his/her name & email address on the entry summary form where requested.

FACILITY NOTE: The Fishers High School Aquatic Center is one of the most beautiful high school facilities in the USA. It is important that all people attending this meet, whether it is swimmers, coaches, or spectators, treat this facility with the utmost care. The following rules will be strictly enforced:

1. Keep all trash picked up (swimmers and teams in particular).
2. Do not go, or let children go, in any unauthorized areas. This means any place other than the lobby or seating areas. Due to USA Swimming insurance requirements, **only** swimmers, coaches, officials and volunteers are allowed on deck. **There can be no exceptions!**
